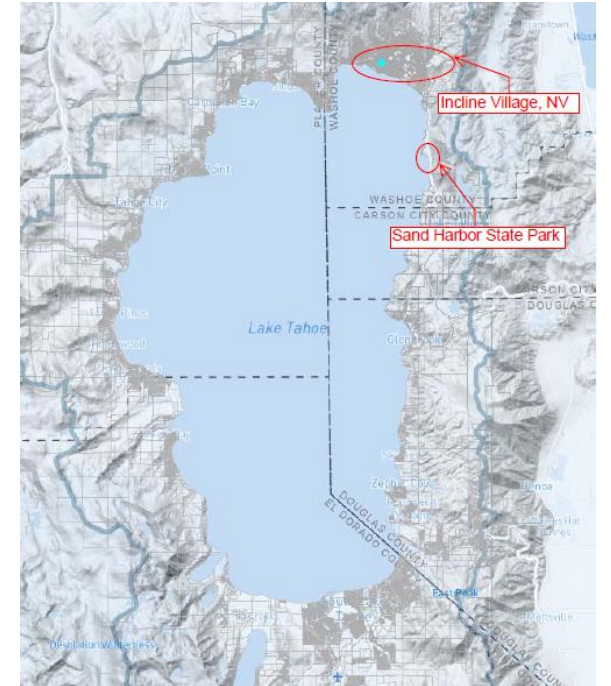

- File #ERSP2021-0673 approved by TRPA Hearings Officer: May 26, 2022.
- Hearings Officer approval was appealed.
- Temporary Use operated during 2022 Summer.
- Appeal heard by TRPA Governing Board: October 26, 2022
  - Appeal was not granted.
  - Governing Board directed that the permit extension, incorporating revised conditions, be brought back to Governing Board for approval.

TRPA Governing Board requested following items be incorporated into a revised permit, authorizing the six-month extension:

1. Improved Signage
2. Staff Training
3. Opening the gates at the primary parking lot earlier

6. Improved Coordination with Nevada State Parks
7. Parking on paved areas only
