Petition title: Tell Authorities: No Herbicides In Lake Tahoe!

Petition language

Please deny the permit to use herbicides in any waters connected to Lake Tahoe until all non-chemical methods have been thoroughly tested.

Laminar flow aeration, UV light, mats and restoring the lagoons back to natural wetlands are all non-chemical methods that have not been fully tested. By the Lahontan Water Board's own Basin Plan, you are required to exhaust these methods before considering any chemical treatment.

In addition, the EPA classifies Lake Tahoe as a Tier III Outstanding Natural Resource Waterway that cannot be degraded.

State Water Board regulations require you to maintain the "the highest water quality consistent with the maximum benefit to the people of the State." Yet allowing herbicides will benefit mainly boat owners at the Keys, a microscopic subset of the people of California, without eradicating the weeds.

Climate Change and the Caldor Fire have signaled a crisis for Lake Tahoe. We need to restore its natural systems to allow ecosystem functions to heal the Lake. Pouring chemicals into Lake Tahoe will only place a toxic Band-Aid on the gaping wound of the unnatural, stagnant, increasingly warmer lagoons and nutrient loading of the Tahoe Keys, without addressing the underlying cause.

Please deny the permit to use herbicides. Thank you.
