BUILDING RESILIENCY: CLIMATE CHANGE & SUSTAINABILITY STRATEGIC INITIATIVE

Every TRPA initiative includes strategies to strengthen the resilience of Tahoe's environment, communities, and economy to the emerging stresses of climate change and to improve the region's sustainability. The Climate Change Strategic Initiative harmonizes the goals of both states and local governments in the Tahoe Region while maintaining the region's reputation as a global leader in sustainability.

Climate Smart Code: TRPA was selected to work with a group of students as part of a UC Davis policy clinic. The students will help analyze and draft code language for sustainability and equity based on Governing Board input from the October 2022 meeting. Board input on specific code language will be sought in the first half of 2023.

Climate Resilience Dashboard: Staff released a request for proposals (RFP) for consultant support in developing an updated climate resilience dashboard for the Tahoe Region. The dashboard metrics will be developed with stakeholder and Governing Board input with anticipated project completion in March 2024. KEEPING TAHOE MOVING: TRANSPORTATION & DESTINATION STEWARDSHIP STRATEGIC INITIATIVE

This initiative includes an update of the Regional Transportation Plan/Sustainable Communities Strategy, which encompasses greenhouse gas (GHG) reduction, the work of the Bi-State Consultation on Transportation, destination stewardship planning, and ongoing transportation corridor planning.

Collecting Data to Inform Transit Planning: Throughout 2022, TRPA worked with the Tahoe Transportation District (TTD) and Tahoe Truckee Area Regional Transit (TART) on multiple transit surveys to support and inform transit planning, scheduling, and route design. A report summarizing the findings will be published in February. The report will include onboard transit passenger surveys conducted in January and July 2022. Respondents answered questions about trip origin and destination, trip purpose, frequency of transit use, and overall experience on TTD and TART buses. Staff also conducted the Unmet Transit Needs survey from October through December 2022. This survey focused specifically on identifying needs of riders not currently met by public transportation.

Tahoe Trails Strategy: The Tahoe Regional Trails Strategy (formerly the Tahoe Regional Trails Plan), is nearing completion with TRPA staff soliciting steering committee and stakeholder input before releasing a public draft. The strategy is expected to be endorsed by committee members and finalized in March 2023. More information can be found at tahoetrailsplan.org.

Vizion Zero Strategy for Tahoe: TRPA is moving forward with the Vision Zero Strategy, an update to 2019's Safety Strategy. The Vision Zero Strategy will be based on the principles of vision zero, aiming to achieve significant declines in roadway fatalities and serious injuries, with a long-term goal of zero. The strategy will analyze crash data, determine high-risk locations, and provide data-derived recommendations for roadway safety countermeasures and projects. Staff will be convening a technical advisory committee meeting at the end of January that will kick-off the Vision Zero Strategy and the Active Transportation Plan updates.

Transportation Equity Study: TRPA is continuing work on the Transportation Equity Study and currently developing draft policy language and proposed agency action items to improve transportation equity and access for all those living, working, and visiting the

Tahoe Region. Staff and project consultants are preparing a policy discussion workshop for the February Governing Board meeting.

RESTORATION BLUEPRINT: ENVIRONMENTAL IMPROVEMENT PROGRAM

This initiative focuses on accelerating the pace and scale of Environmental Improvement Program (EIP) implementation to keep pace with current threats and to build resiliency to climate change. The EIP has a proven track record over 25 years. This bistate, cross-boundary restoration partnership



has implemented more than 700 projects to improve the environmental and economic health of the Tahoe Basin. To build on the program's success, TRPA staff are accelerating project implementation on multiple fronts including streamlining EIP project permitting by "Cutting the Green Tape," augmenting program funding, and building partnerships at the national and regional levels.

Stormwater Management: Over the next month Stormwater Management Program staff will be sending out letters to priority commercial and large multi-family properties in Nevada reminding them to maintain BMPs or notifying them of their failure to install Best

Management Practices (BMPs) on their property. TRPA staff worked with Douglas and Washoe Counties and the Nevada Tahoe Conservation District to identify priority properties. Information on BMPs and the Stormwater Management Program can be found at www.tahoebmp.org.
