## *KEEPING TAHOE MOVING:* TRANSPORTATION & DESTINATION STEWARDSHIP STRATEGIC INITIATIVE

This initiative includes an update of the Regional Transportation Plan/Sustainable Communities Strategy, which encompasses greenhouse gas (GHG) reduction, the work of the Bi-State Consultation on Transportation, destination stewardship planning, and ongoing transportation corridor planning.

#### Funding for Implementing Transportation Projects

To accelerate implementation of the Regional Transportation Plan, TRPA in its role as the Tahoe Metropolitan Planning Organization is releasing the 2023 Regional Grant Program - Cycle 5. The program allocates funding apportioned to the region to transportation projects through a competitive process. The agency will make the Call for Projects announcement in early November 2022, which will include multiple funding sources that can be combined, when possible, to increase success and effectiveness of project

implementation. Available funding is estimated at \$14.3M for federal fiscal years 2023/24, 2024/25, 2025/26 and includes:

- Congestion Mitigation and Air Quality (CMAQ) \$3M
- Surface Transportation Block Grant (STBG) \$7M (CA \$4M / NV \$3M)
- Active Transportation Program (ATP) MPO \$2.9M
- Carbon Reduction Program (CRP) \$1.3M (CA \$800k / NV \$500k)
- NV Transportation Alternative Program \$123k

Additionally, staff continues to work with the partner agency implementers to identify other funding opportunities to fill funding gaps and implement regionally significant projects.

#### US50 East Corridor Management Plan Draft Recommendations

Complete transportation planning, which incorporates improving safety, connecting trails for bike and pedestrian travel options, parking management and transit improvements all come together in the US50 East Corridor Management Plan. Public listening sessions on the draft recommendations are scheduled for later this month and early November.

#### The Lake Tahoe Destination Stewardship Plan Seeks Input

During the months of October and November, the Lake Tahoe Destination Stewardship planning team will seek additional input from the community and business leaders

through the form of a resident survey and four public workshops. The resident survey is open through October and can be accessed through these web links: <u>English</u> and <u>Español</u>.

The community workshops will on October 25 and October 26 and are opportunities for members of the public – including residents, business owners, and local workers – to hear what the planning team has learned from their research and stakeholder consultations. Outcomes from the workshops will deepen the understanding of key issues the Destination Stewardship Plan should address and help shape a shared vision for tourism and outdoor recreation in Tahoe. The workshops will be facilitated by the plan's consultant team: the Center for Responsible Travel and the Travel Foundation.

#### TAHOE LIVING: HOUSING & COMMUNITY REVITALIZATION STRATEGIC INITIATIVE

This initiative addresses strategies for implementing affordable and achievable workforce housing as a key component of healthy, sustainable communities in the region. The Tahoe Living initiative implements the Regional Plan, the Regional Transportation Plan/Sustainable Communities Strategy, the Regional Housing Needs Allocation, and other identified regional housing needs.

## Tahoe Housing Catalyst Program/California Regional Early Action Planning Grant (REAP 2.0)

On September 28 TRPA staff received input from the Local Government and Housing Committee (LGHC) on draft evaluation metrics for the Tahoe Metropolitan Planning Organization (TMPO) allocation of the REAP 2.0 program. As the MPO for the Tahoe Region, TRPA is eligible to receive and distribute more than \$600,000 of funding from this program. TRPA is modifying the evaluation metrics to incorporate LGHC and public feedback and then will use the metrics to evaluate the projects or programs that could receive a portion of these funds to advance the priority actions identified by the Tahoe Living Working Group.

At the November Governing Board meeting, staff will ask the board for authorization to submit the application to the State of California for REAP 2.0 funds. Concurrently, TRPA and partners are exploring the feasibility of applying for a larger, competitive program within REAP 2.0, called the Higher Impact Transformative grant program.

#### **RESTORATION BLUEPRINT: ENVIRONMENTAL IMPROVEMENT PROGRAM**

This initiative focuses on accelerating the pace and scale of Environmental Improvement Program (EIP) implementation to keep pace with current threats and to build resiliency to climate change. The EIP has a proven track record over 25 years. This bistate, cross-boundary restoration partnership



has implemented more than 700 projects to improve the environmental and economic health of the Tahoe Basin. To build on the program's success, TRPA staff are accelerating project implementation on multiple fronts including streamlining EIP project permitting by "Cutting the Green Tape", augmenting program funding, and building partnerships at the national and regional levels.

#### AIS Inspection Fee Update

To ensure effective and sustainable operations of the Aquatic Invasive Species Watercraft Inspection Program, the TRPA Code allows for the collection of a fee to cover those costs that is to be reviewed and approved by the Governing Board. Inspection fees are complemented by federal and state (both CA and NV) funding. Staff is compiling this season's data and will present the proposed fee schedule for the 2023 season at the December 2022 Governing Board meeting for consideration. The new fee schedule will be effective January 1, 2023.

#### **DIGITAL FIRST: INNOVATION INITIATIVE**

This initiative recognizes the agency's unique ability to address external events, technology changes, and pursue continuous improvement. It involves significantly improving the ability of the agency to provide services in a "digital first" way by rethinking processes and, using innovative technology.

#### **Document Scanning & Digitization Project**

TRPA received a \$250,000 American Rescue Plan Act grant from the Nevada Coronavirus State and Local Fiscal Recovery Funds, recently issued a Request for Proposals for document scanning and digitization contractors, and expects to have a vendor selected by the end of November with a project start date before the end of the year. The goal of the project is to scan up to 20,000 agency records and documents through the first year of this project.

The agency has already digitized more than 15,000 paper files on its own. There are currently approximately 200,000 remaining files to scan. Additional funding for the project has been requested from California and Nevada through the regular budget processes.

#### **Project Permitting**

Following the Innovation Initiative presentation at the August 24, 2022, meeting, Governing Board members requested information about the number of recent TRPA applications and project review performance measures. This information is provided in the tables below. Through the first three quarters of 2022, TRPA has received 884 permit applications – more than submitted in all of 2021, and 10 percent higher than received during same period in the 2021, when TRPA received the highest number of applications ever recorded.

In the previous quarter, 100 percent of applications received were reviewed for completeness within 30 days of application submittal, which is the agency's stated goal. Ninety-six percent of permits were issued within 120 days of TRPA receiving a complete application. Out of the 166 applications currently in review, eleven applications have exceeded 120 days in TRPA review time, all of which are shorezone or buoy applications being reviewed under newer ordinances.
