


## **To Participate Online:**

- 1. Download the Zoom app on your computer, tablet, or smartphone.
  - The computer app can be downloaded here: <a href="https://us02web.zoom.us/client/latest/Zooml">https://us02web.zoom.us/client/latest/Zooml</a>
     <a href="nstaller.exe">nstaller.exe</a>
  - The tablet or smartphone app can be found in the app store on your device.
- 2. On the day of the meeting, join from the link or phone numbers posted under the appropriate meeting date and time on the TRPA website (www.trpa.gov).
- 3. Ensure that you are **connected to audio** either through your computer (provided it has a microphone) or using your phone as a microphone/speaker. You can manage your audio settings in the tool bar at
