### TRPA HOSTS PUBLIC SHOREZONE MEETING ON JANUARY 9

**Lake Tahoe, CA/NV** – The Tahoe Regional Planning Agency is hosting a meeting on Tuesday, January 9, where the public is invited to hear an informational presentation on the shorezone at the Kings Beach Conference Center from 6 to 9 pm. The meeting is designed to explain the proposed shorezone program and to answer the questions of community members.

Additionally, a special meeting of the Advisory Planning Commission will be held for the shorezone on January 17, 2007 at the Tahoe Regional Planning Agency office on Kingsbury Grade, Stateline, NV. The meeting will begin at 9:30 am. The APC will hold a public hearing and is expected to vote on whether to recommend adoption of the shorezone program and ordinances to the TRPA Governing Board.

After more than two decades of working with the public on the shorezone plan, TRPA is hopeful the proposed program finds middle ground that ensures the protection of Lake Tahoe and honors the concerns of the community, according to John Singlaub, TRPA's Executive Director. The Governing Board is expected to vote on the final shorezone document and proposed ordinances on January 31 at a special meeting at the Kings Beach Conference Center.
